## Oresa and entrepreneur Cristian Amza take over control of La Fântâna from Innova Capital

On 14th April, Oresa together with founder Mr. Cristian Amza, signed the agreement for the acquisition of all shares held by the funds managed by Innova Capital in La Fantana Group. Completion of the transaction is subject to the customary approvals, and the price of the transaction has not been disclosed.

La Fântâna is a leading provider of home and office water solutions in South-Eastern Europe (SEE) and the second largest provider of water solutions in Central and Eastern Europe (CEE). In 2015 the La Fântâna Group posted consolidated revenues of over EUR 42 million and served more than 50 thousand customers.

The Group led by Cristian Amza has effectively shaped the Romanian and Serbian water solution markets and currently operates an integrated business with a nationwide coverage in both Romania and Serbia, spanning the entire chain from water source to water production/bottling facilities and further to the Group's own water and coffee distribution, and logistics for delivery to customer premises.



"La Fântâna has been growing considerably in the past 17 years with Innova Capital and Oresa aside. We have shared the same vision in a team that worked every time. I thank the investors for believing in La Fântâna and the management team I've been leading. Personally, I am extremely happy to re-join Oresa as partners. Our ambition is to continue to grow the business and demonstrate how the right equity investor and an outstanding entrepreneur can partner to build great businesses" – says Cornel Marian, Managing Director of Oresa. "We are very satisfied, with what we managed to achieve together with the Management of La Fântâna during our holding period. Since the entry in 2007 the Company almost quadrupled EBITDA profit, and developed strong market position in new segments like office coffee and POU-filters. We are confident that this track-record will be continued by the

Management, under new ownership structure" – added Sebastian Teter, Managing Director of Innova Capital.
